

COUNSELLING NOTICE – MA (3RD ROUND)

It is for the information of all aspirants, who have applied for **MA programme** that due to COVID-19 situation, TIET has decided to do the admissions for session 2020-21 through online mode. A zoom meeting will be arranged for all the candidates by TIET where you will be meeting the Head of the school and the admission committee for verification of the documents. Please follow the below mentioned steps to participate in the counselling.

1. All the candidates who have applied and fulfil the prescribed eligibility criteria, shall be considered and admissions shall be made as per merit.
2. **Keep the scanned copies of the following essential documents (preferably in single pdf) ready before the start of the counselling.** When asked by the admission committee during counselling, you are required to send the scanned copies of essential documents through your registered email id (as mentioned in your application form) to email-id of the Admission Committee mentioned in point - 3.
 - i. Graduation DMCs (upto pre-final year as prescribed in the eligibility criteria)
 - ii. 10+2 DMC
 - iii. Matriculation/Higher Secondary Certificate (Date of Birth)
 - iv. Admission Application Form
 - v. Reserved Category Certificate on the prescribed Performa and signed from the competent authority*
 - vi. Undertaking, if result of final exam is not declared*

Rest of the documents as per the checklist mentioned at the end of this notice can be submitted by the candidates as and when you join the institute physically.
